PROFILE

Craig B. Merkle is one of the founding partners at GDL D and has been actively involved in trial practice since 1982. His practice is concentrated in professional malpractice defense, pharmaceutical and medical device litigation, hospital litigation and professional disciplinary and licensing actions. In addition, he has handled a variety of general litigation matters arising in contract and tort.

Mr. Merkle is a Fellow in the American College of Trial Lawyers (ACTL) and a member of the American Board of Trial Advocates (ABOTA). He has also been repeatedly recognized for excellence in his practice by Chambers U.S.A., Super Lawyers and Best Lawyers.

Professional Liability Claims. Mr. Merkle has represented physicians and health care providers in virtually every medical specialty, as well as community hospitals and academic medical centers throughout the State of Maryland. Representative self-insured institutions and insurance company clients include: The Doctors Company, University of Maryland Medical System, Mercy Medical Center, Upper Chesapeake Health System, Ascension Health, and St. Agnes HealthCare, Inc. Mr. Merkle has tried to verdict numerous cases in the Circuit Courts of Maryland, United States District Court for the District of Maryland and the Health Claims Arbitration Office.

Pharmaceutical and Medical Device Litigation. Mr. Merkle is actively involved in the firm's medical drug and device practice. He has been lead trial counsel for multiparty trial groups in the diet drug litigation in the Court of Common Pleas in Philadelphia, Pennsylvania. In addition to serving as trial counsel, Mr. Merkle has been responsible for conducting discovery, case work-up, expert development and serving as the liaison for local counsel. He has also been involved in the evaluation, discovery and work-up of lawsuits arising from prosthetic knee implants and the investigational study of diabetes drugs

Professional Disciplinary, Privileging and General Hospital Litigation. Mr. Merkle has represented academic and community health care systems in a number of matters which extend beyond the professional liability arena where he frequently practices. For example, he is often requested to provide counsel and guidance to hospital leadership on issues concerning privileging and employment disputes, impaired physicians, boundary violations, and breach of professional and fiduciary obligations. This representation involves complex problem solving challenges in an effort to balance the safety of patients, the common law and statutory obligations of the institution and the due process rights of the involved health care providers. Mr. Merkle has represented hospitals in lawsuits arising from denials and restrictions of hospital staff privileges. Theories of liability typically include antitrust, breach of contract, civil rights, conspiracy, interference with contract, defamation, and interference with prospective business advantage. He has also been involved in the defense of hospitals in wrongful discharge suits brought by health care providers. Mr. Merkle has also represented physicians, nurses, dentists, podiatrists, and other health care providers in disciplinary actions and investigations before the Board of Physicians and other state licensing boards.

Other Civil Litigation. Mr. Merkle has represented individuals, partnerships and corporations in a wide array of litigation matters arising in tort and contract. For example, he represented a major manufacturer of dental equipment and supplies in recovering damages under a Licensing Agreement following a product recall of the licensed product by the FDA, FTC and EPA. He represented a hospital system in a series of lawsuits and claims arising from multiple patient deaths allegedly due to the outbreak of Legionella. He has also been involved in the defense of building products used in commercial and home construction.

Representative Trials:

Crowder v. Flynn, Circuit Court for Anne Arundel County, Maryland (2008). Defended general surgeon in a claim involving necrotizing fasciitis after alleged perforation of bowel during repair of extensive hernia with mesh.

Hayes v. CWC, Circuit Court for Anne Arundel County, Maryland (2007). Obtained defense verdict for obstetrician/gynecologist in medical malpractice claim alleging permanent injury, scarring and disfigurement following MRSA infection in the breast. Plaintiffs alleged negligent diagnosis and treatment of mastitis following childbirth.

SBL v. Annapolis OB/GYN, Circuit Court for Anne Arundel County, Maryland (2007). Obtained defense verdict for obstetrician/gynecologist in medical malpractice claim alleging permanent injury, disfigurement and post traumatic stress disorder due to labial agglutination following traumatic childbirth.

Garvey v. Morris, Circuit Court for Anne Arundel County, Maryland (2006). Obtained defense verdict for gynecologist in medical malpractice claim alleging permanent injury, disfigurement and surgical reconstruction due to vaginal foreshortening following hysterectomy.

Disney v. McClain, et al., Circuit Court for Anne Arundel County, Maryland (2005). Obtained defense verdict for obstetrician in medical malpractice claim alleging \$6 million in damages for cerebral palsy and brain damage due to pre-term delivery of infant claimant.

McCormick v. Strider, Circuit Court for Calvert County, Maryland (2005). Obtained defense verdict for gynecologist in medical malpractice claim alleging massive bleeding and infection with multiple surgeries and hospitalizations following hysterectomy.

Hansen, et al v. Wyeth, Court of Common Pleas, Philadelphia, Pennsylvania (2004). Lead trial counsel in defense of multi-plaintiff suit v. Wyeth, alleging valvular heart disease from ingestion of diet drugs. Jury returned verdicts in favor of four plaintiffs in the trial group. On post trial motions, however, the defense obtained entry of judgment notwithstanding the verdict based on the doctrine of assumption of the risk as to one plaintiff, and an order for new trial as to the remaining plaintiffs due to the improper and conclusory testimony of plaintiffs' liability expert.

LeMaster v. Yousefi, Circuit Court for Montgomery County, Maryland (2004). Obtained defense verdict for plastic surgeon in medical malpractice claim alleging lung injury and other complications during breast implant surgery.

Rice v. Wise, Circuit Court for Charles County, Maryland (2003). Obtained defense verdict for orthopedic surgeon in medical malpractice claim alleging permanent damage due to misdiagnosis of complete quadriceps tendon rupture.

James Kernan Hospital, Inc. v. Ambition Health Care Services, Circuit Court for Baltimore City, Maryland (2002). Obtained jury verdict for full recovery of contribution for University of Maryland Medical System in claim against nursing agency arising from settlement of wrongful death of 19 year old patient.

Lyon v. Dentsply International, Inc., American Arbitration Association (2002). Obtained judgment in favor of Dentsply International in dispute over termination of company manager following sale of subsidiary and assignment of executive employment contracts.

Unnamed Physician v. Upper Chesapeake Health System, Administrative Hearing, Harford County, Maryland (2002). Successfully represented the medical staff of the health system in a full evidentiary administrative appeal brought by physician whose active staff privileges were suspended and subsequently revoked due to imminent danger to the health and safety of patients in the system.

Hevey v. Hill, Circuit Court for Baltimore City, Maryland (2001). Obtained defense verdict for hand surgeon in medical malpractice claim alleging amputation due to failure to treat infected wounds following crush injury.

Thomas v. Gorbaty, Circuit Court for Anne Arundel County, Maryland (1998). Obtained defense verdict for hematologist in medical malpractice claim alleging amputation of leg due to delay in diagnosis of compartment syndrome.

Hammond v. Barr, Circuit Court for Montgomery County, Maryland (1997). Obtained defense verdict for internist in medical malpractice claim alleging permanent brain damage from delay in diagnosis of subarachnoid hemorrhage.

Jacobs v. McCormack, Circuit Court for Howard County, Maryland (1997). Obtained defense verdict for rheumatologist in medical malpractice claim alleging paraplegia from delay in diagnosis of epidural hematoma.

Appellate Practice. In addition to his trial experience, Mr. Merkle has extensive appellate experience. For example, Mr. Merkle successfully handled the appeal in which the Maryland appellate court refused to recognize a duty by health care providers to warn friends and family members of a patient's HIV status.
